No-Smoking Rule

Princeton Place at Wiggins Bay One Association, Inc., has adopted by the membership No-Smoking Rule to acknowledge and to acknowledge and agree to the rule with Sales Application.

Please review and sign below.

Smoking Prohibited

a. Definitions

- i. “Smoking” means inhaling, exhaling, burning, or carrying any lighted or heated cigar, cigarette, or pipe, or any other lighted or heated tobacco or plant product intended for inhalation, including hookahs and marijuana, whether natural or synthetic, in any manner or in any form. “Smoking” also includes the use of an electronic smoking device which creates an aerosol or vapor, in any manner or in any form.
- ii. “Electronic Smoking Device” means any product containing or delivering nicotine or any other substance intended for human consumption that can be used by a person to simulate smoking through inhalation of vapor or aerosol from the product. The term includes any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, e-cigarillo, e-pipe, e-hookah, or vape pen, or any other product name or descriptor.

b. Smoking is prohibited on all Common Elements of Association. Without limiting the generality of the foregoing, this prohibition applies to all Common Areas, including Limited Common Elements, of the Association, whether indoors or outdoors, including, without limitation, lanais, terraces, stairways, hallways, and landscaped areas of the condominium. The smoking prohibition shall apply to all forms of smoking, including the use of electronic smoking devices.

c. Smoking within the Units is prohibited.

d. This restriction shall apply to all Unit Owners, family members, tenants, residents, guests, business invitees, and visitors of the Association.

e. This restriction is effective immediately upon recording as to all Common Elements and Limited Common Elements.

f. Any Owner who sells his Unit shall specifically disclose to all potential buyers and realtors that smoking is prohibited on all Common Elements and Limited Common Elements. Any Owner who rents or otherwise allows someone other than the Owner to reside within or occupy the Unit shall disclose to all persons who reside within his Unit, prior to their occupancy or residency, that smoking is prohibited on all Common Elements and Limited Common Elements.

g. Each Owner is responsible for the actions of all other persons residing within or visiting his/her Unit and shall be subject to a violation of this Section if any such person is found to be smoking on the Common Elements or Limited Common Elements.

FREQUENTLY ASKED QUESTIONS AND ANSWERS SHEET for Princeton Place at Wiggins Bay Condominium One Association, Inc.

Q: What are my voting rights in the Condominium Association?

A: There are 37 units in the Condominium Association. The owner(s) of each unit have one divisible vote, which may be cast in all matters which require a vote of the owners. Voting rights are described in § 3.5 and § 3.6 of the By-Laws.

Q: What restrictions exist within the Condominium Documents on my right to use my unit?

A: Units are restricted to residential use. See section 17, Occupancy and Use Restrictions, of the Declaration.

Q: How much are my assessments to the Condominium Association for my unit type and when are they due?

A: Please see Budget. Assessments are due January 1st, April 1st, July 1st, October 1st.

Q: Do I have to be a member of any other association? If so, what is the name of the Association and what are my voting rights in this Association? Also, how much are my assessments?

A: Each unit owner has to be a member of the Princeton Place Owners Association and the Wiggins Bay Foundation, which provide certain common facilities and services to the residents of Princeton Place and of Wiggins Bay, respectively. Voting rights are shown in Article V of the Property Owners Declaration and in Article III of the Wiggins Bay By-Laws, respectively.

Q: Am I required to pay rent or land use fees for recreational or other commonly used facilities? If so, how much am I obligated to pay annually?

A: There are no required payments, other than the assessments noted above.

Q: Is the Condominium Association or other mandatory membership association involved in any court cases in which it may face liability in excess of \$100,000? If so, identify each such case.

A: Not that we know.
